<u>Thank you to the HE Team</u> (Cheryl, Amy, Maegan & Valerie) for providing the delicious Cincinnati Chili which was enjoyed by those present.

Additions and Approval of June 2022 minutes were approved with no corrections.

<u>CCE Delaware County Update</u> - Jack Salo thanked the HE team reporting that the EFNEP program is in year five of 5-year contract with \$82,035 received each year. New year began on October 1.

**2023 SNAP/EFNEP Programs** – The EFNEP program provides nutrition education to income-eligible families & children in counties throughout NYS. A series of 8 classes offered to adults in a variety of settings, including by Zoom & phone. See the EFNEP October Newsletter for more information. Amy & Cheryl (EFNEP) work in close collaboration with Meagan (SNAP) offering 6 free cooking & nutrition classes to youth ages 8-12 & adults in person at Stamford Central School & virtually at Roxbury Central School. Refer to the attached handouts. \$61,500 of the EFNEP funds is a direct contract with CCE beginning Oct. 1 with at least 110 families to be served. Next year's grant application will be competitive.

<u>2023 Rural Healthcare Alliance</u> – Currently in the 4th quarter now and in year four of 5-year funding cycle for ACEs task force, Mental Health & Behavioral health services.

<u>General CCE Delaware County Updates</u> – Donna shared that recruiting a Human Ecology Team Lead with search committee has begun explaining that the Executive Director position is a stand alone one. A process has been designed of how advertising would take place with 15 highly qualified applicants narrowed to 8 for telephone interviews (4 today) and (4 tomorrow) to take place followed by in-person interviews, meet & greet with staff, tours and presentations given with goal to be done by November 17 to take final recommendation to the board with December 8 a tentative date for annual meeting with guest speaker being the new Executive Director.

## **Program Updates:**

<u>Fair</u> – Valerie reported about the 5 HE exhibits from local schools & other organizations in addition to the "Saving Money in Many Different Ways" CCE HE exhibit. Blending smoothies by pedaling a bike, playing the Price is Right game that tested ones fall gardening knowledge & an energy display engaged &

informed people. The breastfeeding station continues to be a big hit for Moms and their infants. Refer to the attached fair report.

Excite 2 & 3 – Working on vaccine hesitation.

Walton Farmers' Market - FMNP program - Went well on Fridays from July to September with music.

<u>SNAP-Ed/EFNEP</u> – CROP fall programming, Summer Youth Programs – Amy reported mostly in-person programs but virtual options also offered, lots of health fairs in the fall & focusing on more partnerships with Otsego County with food pantry (St. Mary's).

<u>Energy programming</u> – Cheryl reported outreaches and workshops continuing to help get homes weatherized. Challenges being busy schedules for those able to complete the job working within the 4 year contract with Hubs, engaging stakeholders and looking to get communities involved. Refer to handouts for more information.

<u>Discussion regarding CSA sliding scale</u> along with community & agency partnerships for HE programs beginning simply by welcoming people and asking how can HE help you?
